

CAM Meeting Summary

Tuesday, September 13, 2022, 1:30 PM

1. Introductions and updates:

• Attendee introductions were made. Marilyn Greenblatt of Jewish Family Service said the number of rides have picked up and their focus is on Cycle 12.

2. SANDAG Updates:

• Zach Rivera gave an update regarding SANDAG Cycle 12 Call for Projects. He reminded everyone that applications are due by October 5th, 5:00pm through BidNet for the Specialized Transportation Grant Program. Zach said SANDAG is looking for six to 10 volunteer evaluators that meet the necessary requirements to evaluate applications. Aly Neumann gave updates regarding SANDAG's pilot teleworking program which will run from September through December. SANDAG employees will work using a hybrid format; in the office three days per week and remotely the other two. If successful, the program could be implemented at SANDAG in early 2023. Arun Prem said FACT uses SANDAG as a guide for its policies. Ben Gambler provided an update on SANDAG's AFA program call for projects. He said they are currently in the evaluation phase for Cycle 1 and encouraged applicants to respond to the feedback survey to help with future funding applications.

3. CAM Administrative Updates:

• Budd nominated Marilyn Greenblatt, Director of Transportation at JFS and Marcy Roke, President of Travelers Aid Society of San Diego to the positions of Chair and Vice Chair, respectively. Marilyn and Marcy accepted the CAM member approved nominations. Budd and Arun congratulated Marilyn and thanked her for her dedication to CAM. Budd and Arun congratulated and thanked Marcy for her time and help on CAM. Budd said CAM membership should be updated to stay current. Budd reminded attendees to complete the survey regarding future CAM meetings format by September 25th. A link to the survey is on this meeting's Agenda. Budd announced Ali Poorman, FACT's Mobility Manager, as the new CAM liaison. Ali will manage CAM membership and coordinate meetings going forward.

4. CTSA and FACT Services Updates:

• Arun gave an update regarding the CAM Interagency Referrals Tracking subcommittee. The committee includes Marilyn Greenblatt; Adrianna Ramirez, Travelers Aid; Robert Gebo, NCTD; Ali Poorman, and Arun. The committee will meet with 211 to discuss the involvement of the Community Information Exchange (CIE) in referral tracking. Budd provided an update regarding the FTA Innovative Coordinated Access and Mobility Grant (ICAM) and App Development. This grant will fund research of products and the implementation of a mobile application that will allow riders to schedule trips and pay

fares through a card-based solution working in coordination with CIE and Ecolane software.

5. RideSheet: Coordination Technology, a new open-source ride scheduling software

Kevin Chambers (Full Path Transit Technology), a consultant to state transportation departments, presented RideSheet, a tool funded by AARP that allows small transportation providers to organize their work and move into the digital world. RideSheet breaks down and tracks information integrated with Google Maps and other apps to facilitate scheduling and reporting trips, among other things. Data is easily accessed, archived and used later for reporting, and coordinates networking of providers by sharing information.
